خلاصه مقاله:

The relevance of the study is due to a set of problems that have arisen in the educational environment of the University under theinfluence of technological breakthrough in the life activity of modern civilization. The fundamental reasons for the transformation of the higher education system in all its segments are mainly determined by economic and technological factors. Economic factors of disruptive technologies are carried out at the expense of significant acceleration of production and increase of profit, quality of goodsand services.
